### Memberships

Participation in the Camps is reserved for members of CSEN (National Sports and Educational Center) and FIV (Italian Sailing Federation) with up-to-date annual membership.

Those who have not yet updated their 2026 membership can complete it at the time of registration.

**FIV: – kids 8-12 y.o. 16 € (born between 2014 and 2018)**

**– juniores 13-17 y.o. 21 € (born between 2008 and 2013)**

Note: The fees for residential Camps include a weekly amount of €160 as a reimbursement for meals and accommodation for the entire period of stay (from Sunday evening to Saturday morning).



**Residential camp from 6:30 PM on Sunday evening to 9:30 AM on Saturday morning.**

*The fee includes:* continuous support from technical staff and educators (24 hours a day), lessons in the chosen discipline, 1 E-foil lesson for the Surf-Sail-Kite Camp, 2 E-foil lessons for the Wing Camp, organization of games and activities, all technical equipment for the chosen discipline, canoes and SUPs for excursions, support vehicles, level certificate, liability insurance, camp t-shirt, educational materials, any photos of the Camp, reimbursement for meals and accommodation covering everything related to these items from 6:30 PM on Sunday to 9:30 AM on Saturday.

*The fee does not include:* personal extras and anything not expressly indicated in the program.

**Intensive day camp from Monday to Friday from 9:00 AM to 7:30 PM.**

*The fee includes:* continuous assistance from technical staff and instructors from 9:00 am to 7:30 pm Monday to Friday, lessons in the chosen discipline with the option of multiple outings per day, two E-foil lessons for Wing Camp, organization of all activities, all technical equipment for the chosen discipline, canoes and SUPs for excursions, support vehicles, level certificate, third-party liability insurance, Camp T-shirt, teaching materials, and any Camp photos.

*The fee does not include:* lunch, personal extras, and anything not expressly indicated in the program.

**Reduced daytime camp, Monday to Friday, 9:00 am to 5:30 pm**

*The fee includes:* continuous support from technical staff and instructors from 9:15 am to 5:30 pm, windsurfing or sailing lessons in the morning only, organization of all activities, all technical equipment for the chosen discipline, canoes and SUPs for excursions, support vehicles, level certificate, third-party liability insurance, Camp T-shirt, teaching materials, and any Camp photos.

*The fee does not include:* lunch, personal extras, and anything not expressly indicated in the program.

**Optional fees**

**DAY CAMP LUNCH:** Lunch is not included in the day camp fees. It can be requested upon reservation for an additional weekly fee of €30.

**ADDITIONAL E-FOIL LESSONS:** Additional e-foil lessons, not included in the camp fee, will be paid for in full. 20-minute lesson fee - €66.

**BIKE RENTAL:** A bike is required for transportation during the camp. Residential participants require a bike for the evening commute to the restaurant. Day camp participants require a bike for excursions. Each participant may use their own bike or request a rental (limited availability) at the time of registration. For residential camps, the fee is €30 per week. For day camps, any use will be charged per day and paid for in full (€5 per day).



## Registration procedure

Registration closes 6 days before the start of the Camp. Requests received after this deadline may be accepted by Tabo Surf Center provided that the fee is paid in one lump sum plus a €50.00 surcharge.

Registration is considered complete only with:

1. submission of the online registration form
2. payment of the €200.00 deposit + any 2026 CSEN and FIV membership fee.
3. sending the payment receipt to the secretariat at [prenotazioni@tabosurf.com](mailto:prenotazioni@tabosurf.com)

Payment of the deposit constitutes acceptance of the full contract and these terms and conditions.

The balance must be paid no later than 10 days before the start of the Camp. Failure to pay the balance by this deadline will result in the loss of the place and the deposit being forfeited.

A valid medical certificate of fitness for non-competitive sports must be submitted before the start of the Camp.

## Payment method

The deposit and balance must be paid only after confirmation of availability and the amount has been received from the Tabo Surf Center office.

Payment can be made via:

  - Reason for the balance: Participant's last name and name – Balance for Surf/Sail/Kite/Wing Camp '26 + period.
- Online credit card payment available upon request via the link sent by the office.
- Direct payment at Tabo Surf Center within the deadlines for the deposit and balance.

Conferma del Camp e attività

The Camp will be confirmed once a total of 8 participants have registered. Individual disciplines will be activated with a minimum of 3 participants.

In the absence of wind or adverse weather conditions, water activities will be replaced with sports and educational activities on land, with no refunds.

If the organization is forced to cancel the Camp, only the Camp fee paid will be refunded. Membership fees and any other fees not included in the Camp fee are not refunded.



## Logistic organization

Overnight accommodation is provided in large 16-person group tents (“mega tents”) and, once capacity is reached, in individual tents. The tents are set up in a suitable area made available by the Municipality of Gera Lario, in the immediate vicinity of the Tabo Surf Center base. Meals are included in the residential Camp while day participants may either bring a packed lunch from home or request the lunch provided by the organization for an additional fee.

The organization reserves the right to modify accommodation, meal, or activity locations for organizational or safety reasons without the right to refunds or reductions.

## Cancellation and refund

In the event of cancellation by the participant after the deposit has been paid, the following conditions apply:

- Cancellation communicated more than 40 days before the start of the Camp: 100% refund of the Camp fee paid only;
- Cancellation communicated more than 30 days before the start of the Camp: 50% refund of the Camp fee paid only;
- Cancellation communicated more than 20 days before the start of the Camp: 25% refund of the Camp fee paid only;
- Cancellation communicated less than 20 days before the start of the Camp: no refund.

The membership fee will not be refunded under any circumstances.

If the balance is not paid by the due date, the registration will automatically lapse and the deposit will be retained as a penalty.

In the event of payment of the balance and cancellation:

- If a replacement is not found: €150.00 refunded
- If a replacement is found: the balance paid will be refunded

Tabo Surf Center reserves the right to accept or reject any replacement.

## Participants regulations

Smartphone use is prohibited during the Camp week to encourage socialization. Parents will be informed of the schedule and contact details during the initial briefing.

Participation in the Camp implies respect for Tabo Surf Center's code of ethics and educational approach. Non-compliant behavior may result in early dismissal from the Camp without a refund. To provide a non-



exhaustive list of behaviors that violate Tabo Surf Center's rules, the following are the most common: leaving the group and staff without authorization, inappropriate language, disrespectful behavior, smoking, alcohol use, bullying, violent behavior, and disrupting group activities and life.

### Privacy, use of images and consents

Pursuant to EU Regulation 2016/679 (GDPR), Tabo Surf Center SSD SRL informs that the personal data provided during registration will be processed exclusively for organizational, administrative, insurance, and management purposes related to participation in the Camp.

The data may be disclosed to sports organizations, insurance companies, and collaborators involved in organizing the activities, exclusively to the extent necessary to perform the service.

During the Camp, photographic and audiovisual recordings of participants may be taken. These recordings will be used by Tabo Surf Center SSD SRL for documentary, educational, promotional, and publicity purposes regarding its sports and training activities, through publication on websites, social media, informational materials, and official company channels.

By registering for the Camp, the parent or guardian of the minor participant:

- declares having read this information;
- consents to the processing of the minor's personal data;
- declares having read the MOG (Organizational and Control Model of the Sports Club) and the Code of Conduct, available at <https://www.tabosurf.com/wp-content/uploads/2025/08/MOG-FIV-Tabo-ssd.pdf>, both for the protection of minors and for the prevention of harassment, gender-based violence, and any other form of discrimination against any person, adopted by Tabo Surf Center ssd srl in compliance with Legislative Decree 39/2021 art. 16.
- authorizes the use and dissemination of photographic images and video footage of the minor participant taken during the Camp activities for documentary, informational, and promotional purposes of Tabo Surf Center, including via the website, social networks, and informational materials, free of charge, pursuant to Articles 10 and 320 of the Italian Civil Code and Articles 15 and 16 of the Italian Civil Code. 96 and 97 of Law 633/1941,

Consent to the use of images may be revoked at any time by written notice to Tabo Surf Center SSD SRL ([info@tabosurf.com](mailto:info@tabosurf.com)), without prejudice to the lawfulness of the use of materials already produced and distributed prior to the revocation. Failure to consent or subsequent revocation may limit the minor's participation in group photography and videography taken as part of Camp activities.
